# Extraterritorial Jurisdiction for Subdivisions

Per Minnesota State Statute §462.358, cities may extend their subdivision regulations two miles beyond their jurisdictional borders, into unincorporated areas of the County. This area is referred to as the *extraterritorial jurisdiction*. In these areas, the County's subdivision regulations do not pertain, and the city will have final approval of any subdivision of land. In areas where a township has adopted a subdivision and outside of cities extraterritorial areas, the township has the final approval. Currently, Hawley Township is the only township in Clay County with a subdivision ordinance.

## eCRV - New Legislation

Updated threshold of \$3,000

Beginning January 1, 2020 - Whenever real estate is sold for a consideration in excess of \$3,000.00 a CRV is required. Under \$3,000.00 does not require a CRV.

<u>A new consideration statement</u> – \$500 or less or \$1,000 or less statement will be discontinued and the new \$3,000.00 or less statement will be used. \$1.65 will be collected on any transfer \$3,000.00 or less. We will not reject documents that have the old statements on them.

This is covered under MN Stat 272.115. That statute spells out any exemptions to the above noted change.

#### Homestead Credit

December 15<sup>th</sup> is the deadline to apply for homestead for the 2019 assessment. Contact the City of Moorhead or Clay County Assessor's Office to get details.
