At a town board meeting of Hawley Township, Minnesota, held on the 1<sup>st</sup> day of September, 2020 at 7 .m. at the town hall in said township, Supervisor Euneth Nelson introduced and moved the adoption of the following Resolution, which was seconded by Supervisor Dave Tangen, and unanimously adopted by the town board of supervisors.

WHEREAS, Hawley Township in Clay County, Minnesota, contains a number of roads; and

WHEREAS, Hawley Township declares a number of these roads as town roads and maintains said roads; and

WHEREAS, Nearly all of the township roads have been established by use and/or prescription or by dedication and there may or may not be a record of said roads recorded in the Office of the Recorder of Clay County, Minnesota; and

WHEREAS, the township board of supervisors has determined it to be in the best interest of the township, the public, and all parties concerned to determine and record the location of said duly established town roads; and

WHEREAS, the township board has caused to be prepared this road map indicating the location of said town roads contained in the township; and

WHEREAS, the town board held a public hearing on 5<sup>th</sup> day of May, 2020, at 7 o'clock P.m. and that notice of said hearing was provided according to law.

NOW, THEREFORE. BE IT RESOLVED That the roads and road right of way listed on this Hawley Township Road Map are hereby determined to be the duly established four-rod roads.

BE IT FURTHER RESOLVED, That all town roads which lie upon and follow the boundaries of Hawley Township and adjacent township or other abutting political units, are deemed to lie in equal proportion in the township and the abutting political units, unless expressly indicated otherwise.

BE IT FURTHER RESOLVED, That Hawley Township may accept roads in the future as town roads, which will be recorded by description, survey or map at the time of acceptance.




